Dear Mr. Arendt:

Enclosed you will find the copies of a letter of mine to GSPH of February 14, 1940 and of a letter of Hedwig Michel's of February 15, 1940, to which I refer now generally and to the Post Scriptum of mine particularly.

From the latter you may learn that I had been intending to send a letter to you too already at the time when I had been writing the above mentioned letter to GSPH, that is in the middle of February. I supposed at that time that Hedwig Michel's departure to USA could be fixed soonest, of which I would inform you immediately -, but this was not possible before this week, so that I could not write to you before.

I don't know if the Estero people have received one of my two separate covers, which I have sent by different postal ways to the east and to the west. At all events, however, I have not yet heard anything from there neither as answer of these last double- sending nor as answer of my 100-pages letter, of my letter of July 14,1939 and of a cable of congratulation to the 100th anniversary on October 18,1939.

How do you find this?!? Are these real "Koreshans"?

The fact that I have not heard anything either as answer from you to my letter to you of July 9, 1946 (to which I had added a copy of my letter to the GSPH of July 14, 1939) is only comprehensible for me, if I suppose that you have not received it. Or have you received it and answered too and is your sending lost?

In any case I hope now that you will care about this and write to me soonest what has happened for sausing this strange silence of the Estero folks and yourself.

In particular I beg you to write some lines to Hedwig Michel to New York immediately after the arrival of this letter with enclosures in your box, which then she will find at her arrival in New York.

Further I hope that you will find time to sam send me a copy of your proposed letter to Hedwig Michel to New York and to write me a clearing letter to myself here too Writing in haste I am
