

HAINS' PLEA UPSET

Thornton May Be Guilty Even if Peter Is Insane.

ON TRIAL FOR HIS OWN ACT

Defense Outlines Case and Court Makes Adverse Ruling.

Refuses to Dismiss Indictment, and Defines Status of Defendant—Allows Whole Scandal to Be Introduced.

Prosecutor Called as Witness, but Not Allowed to Say Much—Lawyer Testifies That Cabman Committed Perjury.

New York, Dec. 26.—In line with the common sense which has characterized the Hains trial at Flushing, in which, for example, the closing days of the prosecution were consumed in hearing out the testimony of the defendant's witnesses, the judge today received what appeared to be rather a hard knock in the form of a ruling of Justice Crane. In a formal application for the dismissal of the indictment against T. Jenkins Hains, Jr., who did the shooting on August 16, should be dismissed, and that, therefore, as a matter of course, and Thornton should not be tried as a party to the crime. Justice Crane immediately put a crisp refusal of the application.

H. W. POOR CLOSES

Lone Head of Once Great Wall Street Firm Assigns.

MAY OWE FIVE MILLIONS

New York, Dec. 26.—Henry W. Poor, one of the best-known bankers and brokers of Wall street and for years the publisher of Poor's Manual of Railroads, failed today. His banking and brokerage firm, known as H. W. Poor & Co., with offices at 22 Wall street, made an assignment to Mark T. Cox, of the firm of Robert T. Winthrop & Co., without preference. No statement regarding liabilities or assets was forthcoming today, but as Mr. Poor has been prominent in the financial world for many years, it is believed that his liabilities will reach at least \$5,000,000.
