The River May Now Be Widened at Canal

George F. Rohrbach and a number of the property-owners who are opposed to the re-moval of the Canal street bridge had a conference with Mayor Washburne yesterday. The property-owners agreed to raise the money needed to pay the judgments for the land condemned for the purpose of widening the draw to the required width. They also agreed to give the necessary bond in case the defendants took an appeal. In this way the land can be taken possession of and the work of widening the stream prosecuted at once. It was practically decided on the part of the city not to attempt to disturb the present structure, the property-owners vigorously protesting against the placing of a jack-knife bridge at this point, as has been suggested.

United States District Attorney Milchrist has amounced that he will commence an action at the December term of the United States Court to collect the \$5,000 a month fine for allowing the bridge to remain where it is after the War Department had ordered its removal. It is pr bable that before the case is tried the obstruction will be overcome by the widening of the river and that when navigation opens in the spring the vesselmen will not have reason to complain.

SAID TO HAVE ITS RIGHT OF WAY.

What the Evanston Electric Road Is Alleged to Have Accomplished,

It is understood that the Chicago and Evanston Electric railway company has secured the right of way for its proposed line which is to connect with the North Chicago cable line on Lincoln avenue in the vicinity of the ear-barn. Negotiations were at a standstill for some time on account of the inability of the promoters of the enterprise to settle with the Haley estate. It is understood that this difficulty has been removed and that the company will soon be propared to announce its route and ask for an ordinance.
