DUCKS GOING OVER NIAGARA FALLS.

LOCKPORT, N. Y., Dec. 6.-[Special.]-One of the strangest things that have happened at Niagara Falls in some time, and entirely novel to the oldest inhabitant, are the large flocks of wild ducks which have been going over the falls during the last week. Those that are not killed are stunned and seem bowildered. The largest bag of dozen hunters picked up some 400 in the river below the falls. The ducks are floating down the river in large numbers. The game is shipped to Eastern markets by the hunters. The peculiar fact is that the duck after he gets into the swift current does not seem able to extricate itself.
